

("Adopter") agrees that in consideration of the fee of \$_____ paid to "Rescue Dog Village" (also known as RDV) Rescue Dog Village is allowing Adopter to adopt this dog.

After 14 days the adoption fee is non-refundable and considered a donation.

ALL vet expenses incurred while dog is in Adopter's care, shall be the sole responsibility of the Adopter.

Adopter agrees the dog is to be a family companion and shall provide the animal with a safe home; a quality diet; regular veterinary care; monthly preventatives; adequate exercise; appropriate training and attention.
